Finding of the Fitness to Practise Committee: Professional misconduct

Allegations proven:

That you, being a registered nurse, while employed at Nursing Home X:

On or about 8 June 2011:

- In or around 8.00am, in respect of Ms A, a resident in your care, failed to administer Seroquel tablets as prescribed to her.
- In or around 8:00am recorded in Ms A's Medication Administration Record that you had administered Seroquel tablets to her when you knew, or ought to have known, that this was not the case.
- In or around 8:00am in respect of Mr B, a resident in your care, failed to administer some or all of the following medications to him:
 - 1. Lyrica capsule(s) (200mg); and/or
 - 2. Coversyl Arginine tablet(s) (5mg); and/or
 - 3. Tegretol Retard tablet(s) (400mg); and/or
 - 4. Lanziop (Lansoprazole) (30mg); and/or
 - 5. Lyrica B&S capsule(s) (25mg); and/or
 - 6. Lyrinel XL capsule(s) (5mg); and/or
 - 7. a Domerid tablet; and/or
 - 8. a Calvepen tablet.
